Professional Background

In Memory of Former Director Gordon Lockett

The Locketts'—56 Years Of Dedicated Service

Over half a century ago Board Member Gordon L. Lockett's family began a legacy of service to the Villa Park Community. This year marks the 56th year of Lockett leadership for the water needs of this area.



Completed in 1931 at the cost of \$1,000,000, Santiago Creek and Reservoir provided flood control and a major storage facility for Villa Park.

Henry Lockett, uncle of Gordon Lockett served on Serrano's Board from 1929 to 1960. In 1931 he participated in the completion of the Santiago Dam and Reservoir and led the residents of Villa Park to approve a bond issue which provided funds for the construction of the city's initial domestic water system with water pipes sized to provide service to one house on ten acres.

W. B. Lockett, father of Gordon Lockett was involved in water management in Villa Park in the early 1930's through his Directorship on the Villa Park Mutual Water Company. Serrano Irrigation District managed surface water and Villa Park Mutual Water Company was in charge of well water. Serrano Irrigation District took over the operations of the Villa Park Mutual Water Company in 1957.

Gordon L. Lockett

Gordon L. Lockett, the present family member serving on Serrano's Board was born in Villa Park but moved to Santa Ana at a young age because "before 1931 there was no domestic water supply, no sewer system, no electricity and lots of muddy roads." Gordon attended Santa Ana High School, Santa Ana Junior College and received a degree in business administration from the University of California, Berkeley Campus. His early career included working on his dad's farm and later he had his own orchard in Villa Park. He also worked for the Orange County Planning Department. Mr. Lockett relates "it was relatively calm around here in the 1930's, 40's and 50's but things began to change after he was sealed on the Board in 1961.

In 1969 the water treatment plant was constructed. At that time there were only 600 water services but urbanization was on its way. In 1971 Mr. Lockett was instrumental in the building of the Willard Smith Reservoir, followed by the construction of the Cerro Villa Reservoir in 1973 and the Willard Smith Reservoir II in 1976. Soon construction will begin on more water improvement projects to insure adequate supplies of water to the District's 2,200 service customers.

In the past 56 years the Locketts have contributed to the continued growth and prosperity of Villa Park. They have witnessed the transformation of an agricultural area to an urban city. The community has been fortunate to have such dedicated men providing leadership and management for the water needs of this area.

It is with great sadness and heart-felt condolences, that the Serrano Water District informs our constituents of the loss of our former Director, Gordon Lockett. Mr. Lockett passed away in January of this year.

Mr. Lockett came from a family of water service. His Uncle, Henry Lockett, served on Serrano's Board from 1929 to 1960. His Father, W. B. Lockett, was involved in water management in Villa Park in the early 1930's which included taking over the operations of the Villa Park Mutual Water Company in 1957.

Gordon Lockett moved to Santa Ana at a young age. Before 1931, there was no real water supply, sewer system or electricity. In 1961, Gordon Lockett took a seat on the Serrano Water District Board. From there, Director Lockett was instrumental in the construction of a water treatment plant in 1969, the building of the Willard Smith Reservoir in 1971, the historic Cerro Villa Reservoir in 1973, and Willard Smith Reservoir II in 1976. He retired in 1994.

Former Director Gordon Lockett will be very missed. Our thoughts and prayers are with his family at this time.

System Maintenance

Residents may have noticed staff replacing some of the valves throughout the distribution system.



As part of a proactive preventative maintenance program, SWD routinely exercises various water valves, hydrants, and other water system components. For example, the specific purpose of a valve maintenance program is to ensure proper isolation of main breaks when they occur so that service disruption is minimal.

It is prudent to exercise hydrants and valves every one to two years to ensure operability, to identify valves that need systematic replacing, and extend their useful life. In this next year the residents will likely see staff flushing fire hydrants. This is necessary to ensure the hydrants operate properly.

Irvine Lake Update

The recent rain storms presented a nice surprise for Serrano Water District. In a five day period the lake level increased by over six feet.

What this means to you is that water in the lake will supplement our already purchased water in the lake and the purchased groundwater supplies.

At the end of January, the Santiago Creek was still flowing amidst blue sky and sunshine. Keep your fingers crossed for more rain.
